JS from Clyde Wind Farm attended:

- £360k (£20k given to Crawford) then split in two
- Up to 5% of the money can be used for upfront (£7.5k)
- Same rules apply as to main CWF
- AM asked whether the fund will be repeated Answer not in the same way where it's ring fenced
- £624k per year total contribution from CWF Extension which will be available for regional topics across South Lanarkshire
- Action: GS will check whether there is any option to look at the split between the Community Council's (plus the additional funding that Crawford took from the overall funds
- **Action**: DCC to confirm next steps for funds and quotes from companies to kick start gathering community feedback on what to spend the £143k on (what are the priorities)

Scotland Community Policing Team (Clydesdale & East Problem Solving Team) David Wessencraft

- Intro: Last May there was a reshuffle of resource and the clear majority of police are on 'response' and there are 6 local problem solving police. 2 based in Biggar, 2 Lanark and 2 Carluke plus 2 x Lesmahagow
- Local Problem Solving team usually get involved in persistent issues and will play the community role
- Objective here is that we can spend more time looking to bring in other resources where needed
- Local Problem Solving team are involved in all facets of SLC areas (housing, roads, anti-social etc)
- There is a separate officer who has responsibility for communication of 'watch out's (James Higgins)
- Action: Contact JH @ Police Scotland to see whether we can access crime trends etc. (JMcla) DW to share email & contact details (google him)
 - Questions for him Local crime trends, cybercrime, etc
- AJ asked whether there's an option for Police Scotland to run roadshows to share prevention of crime information/hints with local communities (JM to ask John Higgins from Police Scotland)
- Questions from Deer Cull
 - AM outlined issue with Deer Culling in Wandel
 - Forestry Trust confirmed that the culling was legal and approved however, there was lack of signage
 - DW confirmed that where there's a firearms incident then the armed response unit would
 - MM Confirmed the responsibility that license holders have which doesn't seem to have been adhered to on this occasion
 - DW confirmed that if this incident had been reported at the time of happening then a Response Unit would have attended and been guided by an Overview Unit who may choose to send an Armed Response Unit
 - MM confirmed that normally, with responsible Deer Stalkers that the danger to the public is minimal

Action: Look at forestry commission land acquisition (get info from Malcolm)

- Cllr EH confirmed that Greenhills Care Home are planning to do a substantial extension which is intend to include some level of residential care rather than nursing or assisted living.
